
Public vs. Private Utility Lines (3rd Edition)

This month we will focus on Electrical Infrastructure ownership (see April 2018 newsletter for Sewer ownership information and May 2018 newsletter for Drinking Water ownership information).

Electrical Ownership: Per the City of Hickman's Municipal Code, Chapter 7, Article 4, Hickman is responsible for the electrical distribution system starting at our connection points with Norris Public Power District and running underground throughout the utility easements. The City's ownership includes the primary lines, transformers, junction boxes, pad mount switches, street lights, electrical pedestals, and meters.

The privately owned electrical infrastructure begins at the electrical pedestal where the home or business owners' service line connects to the City's meter. The service line is the electrical wire that connects your breaker box to the electrical meter. The electrical meters are primarily located in the rear yard utility easements, however there are a few properties where the meter is located on the house or structure.

Typical Electrical Ownership for Residential and Business Property



Other Configuration: If your electrical meter is on your house or business, then the City owns all infrastructure up to and including the meter.

ATV Reminders

An all-terrain vehicle, utility-transport vehicle and mini-pickups may be operated in Hickman only between the hours of sunrise and sunset.

The headlight and taillight of the vehicle shall be fully operable and visible. The vehicle shall be equipped with an electric strobe/flashing beacon mounted on the top of the vehicle or a bicycle safety flag which extends not less than five feet above ground attached to the rear of such vehicle.

- The Vehicle shall have a visible, operational brake light system.
- Driver must have a valid Class O operator's license or a farm permit.
- Must wear a helmet or hard hat.
- Have liability Insurance coverage for the all-terrain vehicle.

Important Brush Pile Information

Please be aware the City's brush pile **cannot** accept **any** trash, lumber or **bags with yard waste**. Items allowed are limited to tree limbs, shrubs, leaves, & grass clippings. If prohibited items are found, the Lincoln-Lancaster County Health Dept. could revoke the City's open burn permit resulting in the permanent closing of the public brush pile.

Brush Pile facility keys are available for check out (Monday through Friday—8 am to 5 pm) by residents that live within the city limits of Hickman at City Hall, 115 Locust Street.

Keys can be checked out overnight and returned to the drop

box in front of City Hall or at the front desk.

Please be courteous and return keys within 24 hours to allow others the opportunity to utilize the facility.

Lost keys or keys that are not returned are subject to a \$25 fee.
