DON'T FLUSH THAT !!!

Sewers are designed to take our wastewater and carry it safely to a treatment plant. But other items often get flushed that can create problems. We all need to keep things flowing through the sewer. Poop, pee, and toilet paper? Okay. Everything else? Put it in the trash! Even things that are labeled "flushable" can cause problems in the sewer system. Remember, just because it goes down when you flush, that doesn't mean it's not going to cause a problem.

YOUR CHOICES MAKE A DIFFERENCE.

Don't Flush The Following Items:

- ⇒ Paper Towels
- ⇒ Wipes (even flushable ones)
- ⇒ Cloth or paper rags
- ⇒ Plastic items
- ⇒ Condoms
- ⇒ Feminine hygiene products
- ⇒ Diapers
- ⇒ Kitty litter
- ⇒ Cigarette butts
- ⇒ Dental floss
- ⇒ Latex gloves
- ⇒ Hypodermic needles
- ⇒ Facial tissues
- ⇒ Grease
- ⇒ Gas/oil/solvents
- ⇒ Anti-freeze
- ⇒ Paints
- ⇒ Sewage from septic tanks
- ⇒ Pesticides/herbicides
- ⇒ Toys
- ⇒ Medications



IMPORTANT CHANGES TO PAYMENTS MADE TO THE CITY

Effective January 1, 2018 all credit/debit card transactions will include a service fee of 2.49% of the total transaction amount, \$1.75 for electronic check, and \$2.95 for PIN Debit.

The City of Hickman does not retain the service fees.

Alternate payment options (without additional fees) remain in place and include cash, check, and ACH direct payment.

City of Hickman Snow Removal Policy

The City Public Works Department plows the City Streets/Trails after an accumulation of three or more inches of snow in the following order:

1. Chestnut Street (68th Street)
2. Hickman Road (7th Street)
3. Downtown Business District
4. Residential Streets
5. Residential Alleys
6. City Owned Trails/Sidewalks



To ease snow removal, please remember to remove your vehicle(s) from the City Streets as soon as possible.

Resident Responsibility:

City sidewalks should be cleared of snow and debris within 24 hours after a storm.
