Snow Removal and Fire Hydrant Accessibility

Residential sidewalks are required to have snow removed within 24 hours after the cessation of a snow storm. Please be courteous to your neighbors by not blowing or throwing snow onto other citizen's property, sidewalks, driveways or in the city streets. You can assist the Hickman Volunteer Fire Department by removing the snow around Fire Hydrants in your neighborhood. By locating and exposing Fire Hydrants, the Fire Department can save valuable time in an emergency situation.

The City Public Works Department will plow city streets and trails when there is an accumulation of three or more inches of snow. Please move your vehicles off of the city streets within 48 hours of any winter storm to assist the Public Works crews with continuous snow removal.

Plowing schedule in order of priority: Chestnut Street (68th Street), Hickman Road (7th Street), Commercial Business Districts, Residential Streets, Residential Alleys, City Owned Trails/Sidewalks.

The Hickman City Office will be closed on Monday, February 21, 2022 in observance of Presidents' Day.

CITY OF HICKMAN PROCLAMATION 2022 RECOMMENDATION OF FACE MASKS

In response to the increase of Lincoln-Lancaster County Risk Dial to Severe, the close proximity of the City of Hickman to the City of Lincoln and the ongoing COVID-19 pandemic, including the rapid spread of the Omicron variant, I have issued a Proclamation with the strong recommendation that all individuals over the age of two to wear a face mask while indoors, regardless of their vaccination status, in public places in the City of Hickman, NE, to reduce community transmissions of COVID-19 and to help keep businesses open and operating, encouraging economic growth, and preventing prolonged economic harm, with several exceptions, and to offer support and continuity of Lincoln-Lancaster County's Direct Health Measure regulation that all owners and operators of any building, business, or premises, other than a residence in the City of Hickman, NE, utilize the county's website business resource page and strongly recommend the posting of "Mask Required for Entry" signage: <https://app.lincoln.ne.gov/city/covid19/business-resources.htm>

The exceptions and full proclamation is available at City Hall, the City's website, and have been publicly posted at Hickman City Hall, the Post Office, and U-Stop Market.

The proclamation shall remain in effect through March 20, 2022.

Please take due care and responsibility to wear a facial mask in public facilities where social distancing of continually being at least six (6) feet apart is not always possible.
