Project Update: March 24, 2023

The contractor has made good progress on the box culvert underpass even with considerable weather issues and existing utility setbacks. The new 10" water main is complete and backfill of the culvert underpass is mostly complete. Our top priority right now is to get the street open as soon as possible, and allow the contractor to work on retaining wall and trail paving items under traffic. Prairie View Lane will remain closed for material and equipment staging. As of right now, traffic is expected to resume by the end of March.

Attn: City of Hickman Utility Customers Alternate Day Watering in Effect May 1 thru September 30 Municipal Ordinance No. 2021-13

The following water restrictions shall apply in the enforcement of these regulations due to seasonal lack of sufficient pumping capacity and water supplied to the City's water storage facilities:

- 1. Lawn watering and lawn irrigation by consumers of City of Hickman Municipal Water shall be restricted as follows during the period beginning May 1 and ending September 30 of each year.
- 2. Consumers having odd numbered street addresses shall be permitted to water or irrigate their lawns on Tuesday, Thursday & Saturday.
- 3. Consumers having even numbered street addresses shall be permitted to water or irrigate their lawns on Wednesday, Friday and Sunday.
 - 4. No lawn watering or lawn irrigation shall be permitted on Mondays

Penalties for noncompliance shall be:

First offense: Posted notification on the consumers property

Second offense: Written warning mailed to the consumer

Third offense: \$250 fee added to the consumer's monthly bill from the city

Fourth and continual offenses: \$1,000 added to the consumer's monthly bill from the city

Exemptions:

- A 30 day exemption to the lawn watering and lawn irrigation for those consumers establishing new grass and for seasonal reseeding. *Registration at City Hall Required.*
- Watering restrictions do not apply to washing of cars, driveways, houses, etc.
- Consumers who irrigate with reclaimed water, well or pond water do not need to follow the alternate day watering schedule.
