



**CITY OF HICKMAN
PROCLAMATION
HEALTH AND FACE COVERINGS**

Citizens of Hickman:

To officially address the spread of COVID-19 virus that endangers the health, safety, and welfare of the residents of the City of Hickman, NE, I have issued a Proclamation dated December 8, 2020. This proclamation comes to you with the full support and unanimous votes of the Hickman Board of Health and Hickman City Council Members.

All individuals age five (5) years and older shall wear a face covering over their mouth and nose while indoors in premises open to the general public. Face coverings will not be required under several circumstances.

Those circumstances and the proclamation in its entirety are available at City Hall, the City's website, www.hickman.ne.gov and have been publicly posted at Hickman City Hall, Hickman U.S. Post Office and U-Stop Market.

Please take due care and responsibility to wear a facial covering (mask) in public facilities where social distancing of continually being at least six (6) feet apart is not always possible. Community members and residents, please conduct yourself accordingly, practice social distancing, wear a facial covering (mask) in public, and stay safe.
