Private Utility Lines are NOT Located when Nebraska811 (Call Before You Dig) is Contacted

Examples of private utilities are:

- Underground sewer lines between the City's main and the house/building
- Underground water pipes between the City's main and the house/building
- Underground electrical wires between the house/building and the electrical meter
- Lawn sprinkler piping
- Invisible pet fence wires
- Propane lines from the tank to the house or building
- Propane or other lines going to fire pits, BBQs, Pool heaters, etc.

Spring Upgrades to your Home: Building a Deck, Fence, Shed or Pool?

To ensure building safety, the City of Hickman requires a building permit for many types of home improvement projects. Permit forms are available at the City Hall or online at www.hickman.ne.gov. Permits must be approved **before** work begins.

SOLICITORS PERMITS ARE REQUIRED IN HICKMAN

Any person (not associated with a nonprofit organization) who is going door to door in Hickman passing out fliers or attempting to make sales of any kind must have a permit issued by the City of Hickman and must carry the permit on them while conducting business in the city. Citizens may request to see the permit from any solicitor and are encouraged to report violations of Municipal Code 5-402 to the City Office 402-792-2212 or report online at the following link: <https://hickman-ne.socs.net/vnews/display.v/SEC/City%20Services%7CNuisance%20Abatement>

Important Brush Pile Information

Please be aware the brush pile **cannot** accept **any** trash, lumber or bags. Items allowed in the Brush Pile are limited to tree limbs, shrubs, leaves, & grass clippings. Residents utilizing the brush pile should be aware that if prohibited items are found, the Lincoln-Lancaster County Health Department could revoke the City's open burn permit resulting in the permanent closing of the public brush pile. Brush Pile facility keys are available for check out by residents that live within the city limits of Hickman at the City Office, 115 Locust Street. Keys can be checked out overnight (24 hrs.) and be returned to the drop box in front of the City Office or the front desk.

Lost keys or keys not returned are subject to a \$25 fee.


